We, the following individuals hereinafter known as the "ESCAPEES", or the parents or legal guardians thereof if a minor, do hereby voluntarily request and agree to participate in the room escape on the premises of TRAPPED! ESCAPE THE ROOM.

This agreement shall be legally binding upon us the registered ESCAPEES, and the parents or legal guardians thereof if a minor, our heirs, estates, assigns, including all minor children, and personal representatives; and it shall be interpreted according to the laws of the State of Texas. Any disputes by the ESCAPEES shall be litigated in and venue shall be the State of Texas.

In consideration of TRAPPED! ESCAPE THE ROOM allowing our participation in this activity, under the terms set forth herein, we, the ESCAPEES, and the parents or guardians thereof if a minor, do agree to hold harmless and release TRAPPED! ESCAPE THE ROOM, its owners, agents, employees, officers, members, premises owners, insurers, and affiliated organizations from legal liability due to TRAPPED! ESCAPE THE ROOM ordinary negligence; and we do further agree *that except in the event of TRAPPED! ESCAPE THE ROOM gross negligence and willful and wanton misconduct*, I shall not bring any claims, demands, legal actions and causes of action, against TRAPPED! ESCAPE THE ROOM and/or its associates, for any economic and non-economic losses due to bodily injury, death, property damage, sustained by me and/or my minor child or legal ward in relation to the premises and operations of TRAPPED! ESCAPE THE ROOM, to include escaping or being in one of the Escape Rooms on the premises of TRAPPED! ESCAPE THE ROOM.
